- To hold clinics for patients requiring face-to-face Clinical Medication Reviews (CMRs) i.e. a review of the ongoing need for
 each medicine, a review of monitoring needs and an opportunity to support patients with their concordance with prescribed
 medication
- To undertake clinical medication reviews with patients with multi-morbidity and polypharmacy and implement own
 prescribing changes (as an independent prescriber) and order relevant monitoring tests.
- To see patients in multi-morbidity clinics and in partnership with the multidisciplinary team implement improvements to the patient's medicines, including deprescribing.
- Run own long-term conditions clinics where responsible for prescribing as an independent prescriber for conditions where
 medicines have a large component (e.g. stable angina, warfarin monitoring and dose adjustment).
- Accountabilities Give the 3 to 5 key outputs of the position vis-à-vis the organization; they should focus on end results, not duties or activities.
- To monitor and improve the clinical quality, safety and operational performance of the service.
- To support the Lead Pharmacist and Head of Healthcare in delivering a CQC compliant service.
- Information management Analyse, interpret and present medicines data to highlight issues and risks to support decision-making which are then fed to Clinical Governance.
- Identify and escalate any incidents and risks using appropriate channels
- Ensure learning from the investigation of incidents and complaints are implemented in pharmacy processes
- Working with the Lead Pharmacist and Pharmacy Manager to develop and enforce the formulary. Develop, implement and
 maintain the prison formulary, in liaison with other colleagues, and ensure this is updated onto SystmOne locally when
 changes are made.
- Support the audit process in line with Sodexo audit programme including and disseminate findings appropriately to improve prescribing practice
- Provide education and training to the primary healthcare team on therapeutics and medicines optimisation.
- Support the Prison Pharmacy Manager in providing education and training to the pharmacy team members as required.
- Answer all medicine-related enquiries from GPs, other healthcare staff and patients with queries about medicines.
 Suggesting and recommending solutions.
- Providing follow up for patients to monitor the effect of any changes.
- Implement changes to medicines that result from MHRA alerts, product withdrawal and other local and national guidance, including national prison formularies.
- Manage the repeat prescribing reauthorisation process by reviewing patient requests for repeat prescriptions and reviewing medicines reaching review dates and flagging up those needing a review.
- Ensure patients have appropriate monitoring tests in place when required.
- To support medicines reconciliation within the prison and ensure targets are met.
